Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change issuing a bad check provisions to include obtaining child support credit and spousal support credit.

This bill expands current law, and depending on the amount of the bad check, the penalty is either a felony or a misdemeanor.

Felonies are generally served in a state prison facility if prison time is imposed, and misdemeanor sentences are generally served in county jails if jail time is imposed.

Additionally, one of the penalties under this bill is a Class IV felony, and under state law, probation is presumed for a Class IV felony unless certain provisions are met. See section 29-2204.02 for details.

It is unknown at this time if this bill will have an impact on the number of persons sentenced to prison, jail, or probation.

The Supreme Court estimates no fiscal impact from this bill.

The Board of Parole estimates no significant impact from this bill.

The Department of Correctional Services (DCS) states that this bill will have an indeterminate fiscal impact.

Additionally, any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.
