Explanation of Estimate:

This proposed legislation introduces new provisions for the transfer of insured real property upon the death of the original owner. A beneficiary may be named to inherit the property, but any insurance policy on the inheritance will only be valid for the following sixty days immediately after the death, assuming that any premiums due are paid during that time. The beneficiary does not have to be named on the policy before the policy-holder's death, and does not have a claim on any proceeds of a policy that was paid out before death.

No fiscal impact on the Department is expected.
