**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 1174 provides that once every five years, each state entity submit a report to the relevant legislative standing committee regarding operations of that state entity and each budgetary program and whether there is a need for continuation of the state entity. The standing shall then hold a public hearing on the report.

There is likely to be minimal fiscal impact if any.

First, this would only occur every five years though the bill doesn't provide whether the state entity or legislative standing committee determines the schedule over the five year period. If all entities filed their reports in the same year, there could be an impact on standing committee staffing. Second the bill does not indicate the detail of content of the report. A state agency could technically comply with the requirements of the bill with a minimal amount of effort versus a more detailed report with a significant amount of analysis which could potentially require additional costs.

**Explanation of Estimate:**

LB 1174 requires all state entities to submit a report to the corresponding Legislative Committee every five years to include a review of the operations and each budgetary program, as well as an indication as to the need for the state entity. The Legislative Committee would be required to hold a public hearing on the report with a representative of the state entity in attendance.

Completing these reporting requirements every five years will not have a fiscal impact to the Department of Administrative Services.
